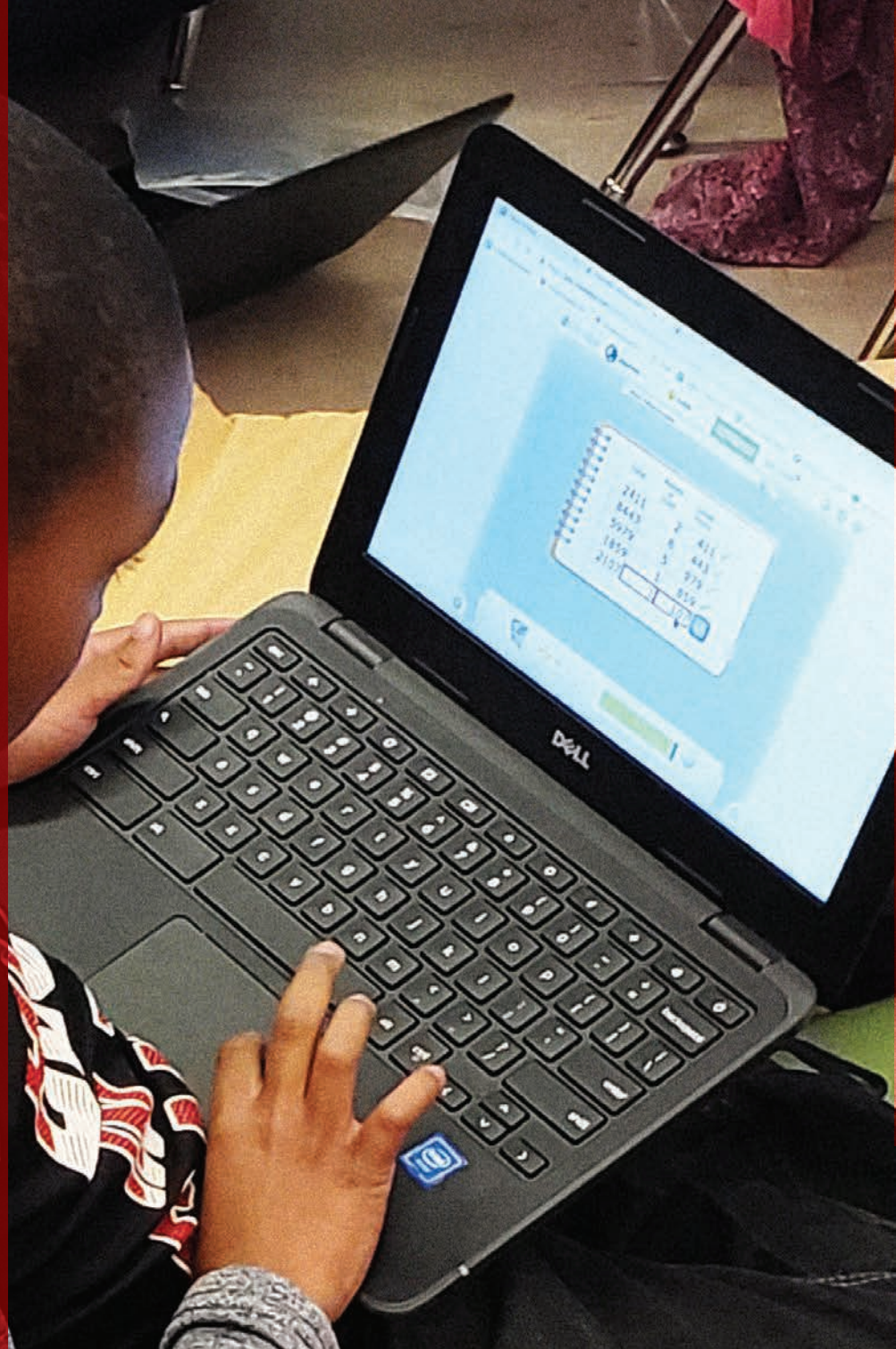

Direction of Support

General Fund

Donations to our General Fund support the work of the Rock Island-Milan Education Foundation and help us make an impact throughout the Rock Island-Milan School District. All donations listed within this Annual Report were received from October 1, 2019 – September 30, 2020.

PRIME Grants

PRIME (Promoting Rock Island Milan Education) Grants provide opportunities for teachers, departments and schools to explore and purchase innovative programs or materials for their classrooms. PRIME Grants are supported, in part, by our Major Saver fundraiser, our yearly allocations for giving, and donations given directly to the PRIME Grant Fund.

Austin Academic Achievement Awards

For 40 years the Austin Academic Achievement Awards has celebrated the academic excellence of our Rock Island High School students. At the Austin Academic Achievement Awards and Scholarship Night, "Top Ten" students are recognized and the top 2 seniors in 8 academic areas are rewarded with scholarships. Generous donations from the contributors listed in this report were made for the awards given via video on May 14, 2020.

Honorarium/Memorial Contributions

Contributions to the Education Foundation are sometimes given to honor or memorialize a family member, friend, community leader, or alumnus/alumna. These contributions may be directed to a scholarship, a program, or to our general fund. These gifts are a wonderful way to remember or honor someone in your life while supporting our students and schools.

Scholarship Contributions

The Education Foundation currently administers 36 named scholarships providing up to 55 individual awards ranging from \$500 - \$5,000. From October 1, 2019 – September 30, 2020, the individuals listed made donations to establish or sustain the scholarships we award to our deserving Rock Island High School Seniors.

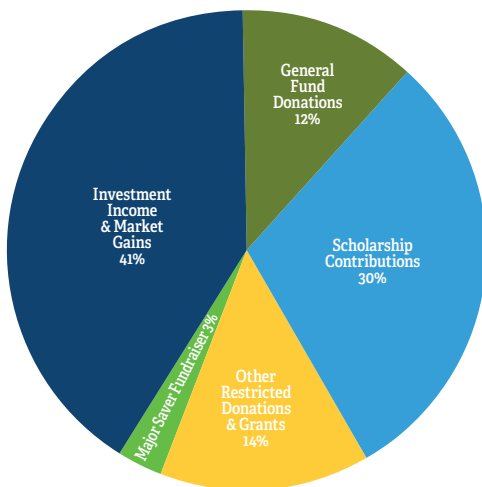
Making a Difference

The challenges presented by this past year were overcome with your generosity. While the shut-down of the school district and remote learning may have restricted the total impact we could provide, thanks to gifts from our individual donors, businesses, community partners, and alumni locally and throughout the country, the Rock Island-Milan Education Foundation gave over \$250,000 to the Rock Island-Milan School District in 2020. With your generosity, the Education Foundation:

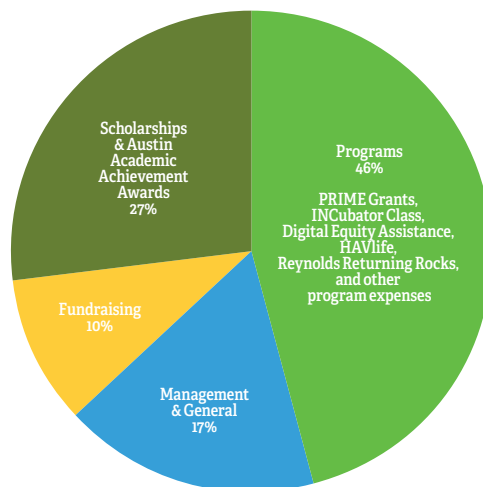
- Awarded 68 RIMEF Named & Austin Academic Achievement Award scholarships totaling \$89,800 and recognized 70 "Top Ten" freshmen, sophomores, juniors, & seniors for the Austin Academic Achievement Awards & Scholarships presented in May.
- Paid program fees for the INCubator.edu class at RIHS and gave funding for "seed money" or other entrepreneurship team expenses - totaling \$7,500.
- Hosted the 2nd year of "Reynolds Returning Rock" program.
- Presented 27 PRIME Grants to 33 teachers totaling \$58,438 for innovative classroom programs and materials in the 2020-2021 school year.
- Presented the school district \$40,277 in support of its "digital equity" efforts providing antennae and 3 years of sustained internet access for students.
- Provided HAVlife funds allowing students ages 10-15 to participate in extra-curricular activities which they otherwise could not afford. For students outside of those age parameters, gave additional financial assistance for Rock Island-Milan based activities.
- Partnered with Spring Forward and the Doris and Victor Day Foundation to provide a comprehensive study on the outcomes on after-school and summer learning programs for district youth.
- Welcomed 33 new teachers, principals, and counselors with "Welcome Bags" filled with nearly \$2,500 in gift cards and supplies to help establish classrooms/offices, Rock Island-Milan Education Foundation information, and other treats.
- Provided over \$36,000 in additional "other" classroom assistance.

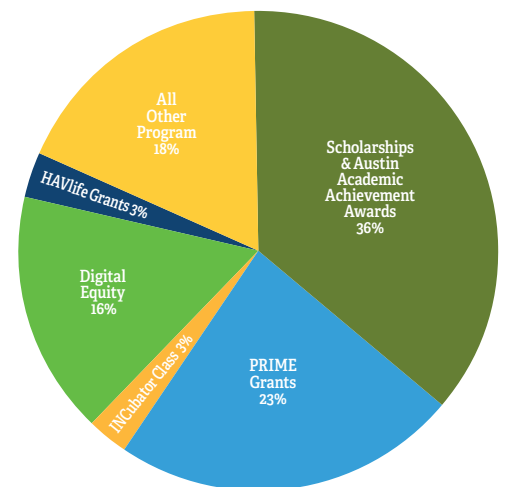
Revenue
